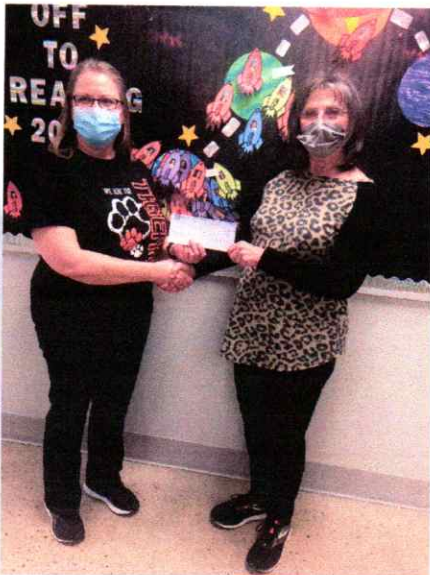
## GCCF Board of Directors decides Grant Allocations for 2021

The GCCF Board of Directors has considered grant allocations for 2021. We are proud to announce the board approved grant allocations totaling \$89,875.00 for 31 endowed funds held in the foundation. For the Donor Advised Funds, Agency Funds and Designated Funds, the donor gets to recommend grant recipients for their fund. All other funds are handled by the foundation board through a competitive grant program.

In addition, there are 18 Demand Funds in the foundation that can make grants from those funds at any time throughout the year. Those funds are managed by the donor with GCCF oversight to assure the grants made are for a charitable purpose.

Through all of these funds, GCCF granted \$137,271.48 during 2020 that all went to local non-profits.

Kansas Children's Service League received a grant for \$3,000 to help with their Child and Adult Care Food Program for the Head Start program in Grant County. Judy Keusler, Executive Director presents the grant.
